About the Fund

The BT Institutional International Sustainability Share Fund invests directly or indirectly in securities listed on stock exchanges included in the DJSI, or expected to be included within three months of listing. This index represents companies that have met certain environmental, social and economic criteria (often referred to as the 'triple bottom line'). Adopting the best of sector approach to screened investments, the DJSI consists of more than 200 companies that represent the top 10% of the leading sustainability companies in 64 industry groups in the countries covered by the broader Dow Jones Global Index.

Fund objective

The Fund aims to provide a return (before fees and expenses) in line with the Dow Jones Sustainability World Index (ex Australia) (DJSI) with net dividends reinvested, as measured in Australian dollars unhedged over the medium term (3+ years).

Investment Team

The Fund is passively managed by State Street Global Advisors, Australia, Ltd (SSgA), which has a long track record in indexed international shares management. SSgA is a wholly owned subsidiary of State Street Corporation which can trace its heritage to 1792. SSgA was established in 1978 to provide innovative, quantitatively driven investment management services to institutional investors. SSgA has been managing portfolios for Australian and New Zealand clients since 1986, with total funds under management of \$79.3 billion as at the end of October 2007. SSgA's international equities strategy provides investors with a broad well-diversified portfolio of international shares. Clients' funds are invested across a diversified range of companies in all major sharemarkets.

Market review

Global equity markets fell sharply in September on continuation of sovereign debt concerns and lower economic growth forecasts. Investors continued to move out of risk assets and into US Treasuries, despite further stimulus by the Federal Reserve, with US bond yields falling sharply over the month.

The MSCI World Net Index fell 8.9% in US\$ terms in September, resulting in the Index being 17.1% lower over the past three months. However in domestic currency terms, the Index returned 0.4% due to the sharp 9.2% fall in the A\$ over the month.

The Dow fell 6.0%, the S&P 500 was down 7.2% and the NASDAQ fell 6.4%, with all markets trading with considerable volatility both over the month and intra-day. Of the 21 trading days in September, 14 had moves greater than 1% in either direction.

European markets were weaker, with the Financial sector the hardest hit as concerns rose, in particular over French banks which are among the largest holders of Greek government debt. The CAC Index fell 8.4%, after falling 11.3% in August. The German DAX fell 4.9% after recording losses of 19.2% in August, the largest loss since September 2002. Spain (-2.0%) and Italy (-4.2%) also experienced falls.

Economic growth in Europe has stalled with many economists now expecting a recession late in 2011 and into 2012. EU GDP growth was just 0.2% for the quarter and 1.6% for the year. The Greek share market fell 12.8% in September after falling 23.9% in August on further austerity measures and a weaker growth outlook.

In Asia, markets recorded losses across the board. Japan (-2.9%), Hong Kong (-14.3%), Singapore (-7.3%), South Korea (-5.9%), Taiwan (-6.7%), Thailand (-14.4%) and Malaysia (-4.2%) all recorded losses.

Fund performance

The portfolio (pre-fee) outperformed the benchmark for the month of September. Key contributors to performance were IBM Corp, Intel Corp, Johnson & Johnson, Vodafone Group and Samsung Electronics. Key detractors to performance were Nestle S.A, Citigroup, BHP Billiton, Rio Tinto and Schlumberger Ltd.
